

# 2006 WELFARE & SAFETY SUMMIT INITIATIVES

- Developed durability statistics of Thoroughbred sires and maternal sires
- Distributing scientific research to industry via website and bi-monthly newsletter
- Passed RCI Model Rule banning use of regular and high toe grabs on front horseshoes
- Developed, tested and implemented a uniform on-track injury reporting system

# 2006 WELFARE & SAFETY SUMMIT INITIATIVES

- In cooperation with Groom Elite, developed a uniform Trainers' Test for first-time applicants
- Passed RCI Model Rule requiring the new national trainers' test and four hours of annual continuing education for trainers' license renewal
- Developing protocols for standardized testing of racing surfaces and uniform monitoring of daily track maintenance

# 2006 WELFARE & SAFETY SUMMIT INITIATIVES

- Proposed RCI Model Rules for uniform vet scratch protocols, drug testing for claimed horses, voiding claims of DNF and vannedoff horses, and auction races
- Eliminated the use of anabolic steroids in racing and horse sales
- Developed interactive tablet PC module to record and database pre-race exams (InCompass RTO)

# 2008 WELFARE & SAFETY SUMMITT

#### 12 public presentations & panels including:

- "The welfare and safety of the horse should be the guiding principle in the decision-making process for all segments of the horse racing industry."
- Create a national media strategy focusing on industry health and safety initiatives

- Create a research and development model for all racing surfaces
- Support research to improve racetrack maintenance equipment
- Establish a central laboratory for timely analysis of racetrack surface materials
- Establish uniform reporting of daily maintenance of racetrack surfaces

- Promote the standardization of pre-race exam protocols and the establishment of necropsy programs in all jurisdictions.
- Correlate all research regarding all equine injuries and fatalities
- Coordinate a blue-ribbon panel on equine racing fatalities
- Create a program with incentives to attract and retain qualified regulatory veterinarians

- Establish national drug-testing laboratory standards, quality assurance programs, and accreditation protocol
- Analyze the drug-testing infrastructure to identify cost efficiencies
- Develop a research and development program for drug testing in the U.S.
- Establish uniform regulation of medication use in sales horses

- Expand the Groom Elite and other educational programs to provide training, certification and continuing education for the backstretch workers responsible for the care and safety of our racehorses
- Pursue strategies to stress horse owner responsibility and ensure that horses are not subjected to inhumane treatment
- Pursue potentialities to create a national self-regulatory structure and/or states' compact for horse racing


