HUMAN SAFETY IN THE CODE OF STANDARDS Injury Reporting and Prevention

- Participation in TJC/InCompass Solutions Equine Injury Database System
- Pre-Race Veterinary Examinations
- Post-Race and Post-Mortem Veterinary Exams
- Veterinarian's List and sharing among jurisdictions



HUMAN SAFETY IN THE CODE OF STANDARDS

A Safer Racing Environment

- Toe Grabs (and other traction devices) restriction of not more than 4mm on Front Shoes
- Approved Safety Helmets and Vests
 - Jockeys
 - Trainers
 - Assistant Starters
- Padded Starting Gate
- Catastrophic Injury Planning and Procedures
- Continuing Education
- Horse Handler Training Like Groom Elite



HUMAN SAFETY IN THE CODE OF STANDARDS Medication and Testing

- Uniform Medication Rules and Penalties
 - NSAIDS, Lasix, Non-FDA Approved meds.
- Ban Exogenous Steroids from Competition
- Ban and Test for Alkalinizing Substances
- Out of Competition Testing
- Frozen Sample Testing
- Controlling Shock-Wave Therapy



HUMAN SAFETY IN THE CODE OF STANDARDS Research & Training

- Racetrack Surface Safety Studies Measurements of track variables
 - Dirt
 - Turf
 - Synthetic

General Racing Related Research Studies



- Jockey Weights
 - Uniform Weigh-out/Weigh-in Procedures
- Jockey Health Information
 - TJC/InCompass Solutions Jockey Health Information System Participation
- Human Ambulance Support Most Important Standard



- Human Ambulance Support - Model Rule:

An association shall provide a properly equipped to transport ambulance, staffed with at least one certified paramedic during training and two certified paramedics during racing hours. If the ambulance is being used to transport an individual, the association may not conduct a race, or allow horses with riders on the racetrack, until the ambulance is replaced.



However, one size does not fit all – some adhering to Model Rule could provide inferior care to some who don't follow to the letter.
